2. Exhibitors and products shall comply with the Participation Provisions for International Pavilion of the 132<sup>nd</sup> Session of China Import and Export Fair.

6. Our company guarantees to strictly comply with the Regulations on Use of online booth(s) of China Import and Export Fair while not transfer, sell or rent out the online booth(s) in any forms.
7. Our company agrees that the information in this Application Form shall be stored in the Organizer's database and used for the promotion of Canton Fair or other trade development by the Organizer or the sub-agent appointed by the Organizer. Our company agrees that the Organizer or the sub-agent appointed by the Organizer shall not be responsible for any error or omission which is not attributable to itself.

The Organizer has fully informed and explained all contents under this Application Form and the Participation Provisions of the 132<sup>nd</sup> session of Canton Fair International Pavilion to our company, we are fully aware of, understand and accept, and confirm that there is no exclusion/restriction of our rights or unreasonable reduction of the obligations of the Organizer or its designated agent.
